The Employer, Al Hussein Bin Abdullah II Technical University (HTU) has received financing from KfW toward the cost of the Promotion of Technical and Vocational Education and Training (TVET) and Accompanying Measure, Phase II and intends to apply part of the proceeds toward payments under the contract of "Procurement of Rehabilitation and Construction Works for Yajouz Vocational Training Institute (VTI) in Jordan."

Al Hussein Bin Abdullah II Technical University (HTU) now invites eligible Bidders to participate in this tender as follows:

- 1) Local Jordanian contractors shall hold the following valid classification as per the Ministry of Public Works and Housing, Government Tenders Department (GTD) classification system:
 - Minimum second (2nd) Grade (or above) Contractors in (Building Construction) or
- 2) JV between two local Jordanian Contractors under the required classification is allowed. Minimum classification for each party is Second Grade (or above) in Building Construction. In case of JV, a letter of intent to form a Joint Venture or association shall be provided as part of the application, acknowledging that the JV members shall be jointly and severally liable for the execution of the Contract in accordance with the Contract terms. Contractors are not allowed to participate in more than one JV or
- 3) International contractors are not prevented from participation. International contractors shall either be registered in Jordan according to national laws and regulations upon award and before contract signing when applying as single entity; or enter into association with a local Jordanian contractor. In case of JV, a letter of intent to form a Joint Venture or association shall be provided as part of the application, acknowledging that the JV members shall be jointly and severally liable for the execution of the Contract in accordance with the Contract terms. The international Contractor is not allowed to participate with more than one JV.

Bidding will be conducted by means of the National Competitive Bidding (NCB) procedures with qualification as specified in the KfW Guidelines for Guidelines for Procurement of Goods, Works and associated Services in Financial Cooperation with Partner Countries ("KfW Guidelines"), under one stage/two envelopes.

The Bid Security shall be valid for at least **162 days** from the Bid submission date. A certified cheque or insurance bond will be rejected, as specified in Section II. BDS Clause 19.1.

<u>Bid opening</u>: Envelopes (1) consist of the Qualification documents and the Technical Proposal in addition to the Bid Security which shall be opened in a public session in the presence of the Bidders designated representatives. The bid opening session shall take place at the:
